Global Property Research announces the final constituents of the GLIO Index Series, which will become effective as of 21 September 2020 (start of trading). The GLIO Index Series is a free float weighted index that tracks the performance of the leading and most liquid infrastructure companies worldwide. Companies are selected on free float shares traded in the past 12 months. Only companies with a minimum weight of 0.02% and a free float percentage of at least 15% are eligible for inclusion. 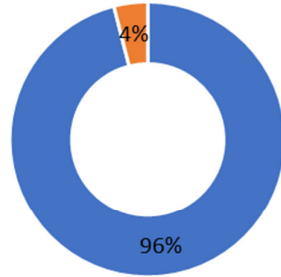

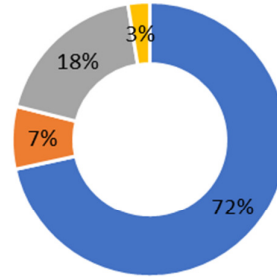

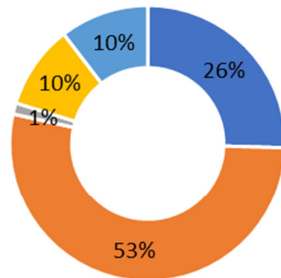

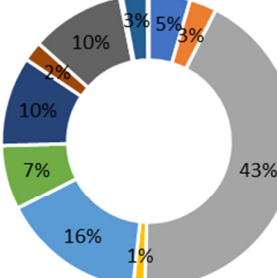
